# What is ACI Air?


The Advance Commercial Information (ACI) program was introduced by the Canada Border Services Agency (CBSA) as a major part of the Customs Action Plan to better manage risks by effectively identifying health, safety and security threats at the border.

ACI requires all air carriers and freight forwarders to electronically transmit conveyance, cargo, house bill and supplementary cargo data to the CBSA four hours prior to arrival in Canada. If the flight is less than four hours in duration, conveyance, cargo and supplementary cargo data must be reported at the time of departure from the foreign airport.

# How does it work?

Our platform allows trade participants to submit the full range of CBSA mandated requirements such as Air Conveyance Reporting (ACVR), and Air Cargo Reporting (ACR) and Split Shipment Reporting (SSR). House bill or Supplementary Cargo Report (SCR) feature is available for shipments consigned to freight forwarders.

Our platform also relays Risk Assessment Notices when applicable. "Hold" and "Hold Cancellation" messages are sent back through the portal. These messages are easily accessed, allowing users to rapidly take the appropriate corrective measures.
