





Importer of Record Services for Singapore

For foreign entities looking to sell into Singapore, there are 3 filing options:

Tax Regime (recover GST)

Section 33(1)

For large B2B companies with an in-house Tax Department

Overseas Principal must:

- Be IRAS registered with own GST registration number
- File tax returns quarterly
- Reimburse the GST balance to IRAS

Section 33(2)

For smaller companies that do not want to be IRAS registered

GeTS provides a comprehensive solution, include:

- Manage IRAS registration
- Be responsible for all import GST payments & collection, filing of GST tax returns quarterly and reimburse the GST balance to IRAS.
- Review Overseas Principal's monthly sales listing

Non-Tax Regime

Not claiming GST


- Import GST (7%) is not claimable.


